MESH COAT

SECTION I STORAGE AND HANDLING INFORMATION

DO NOT STORE ON THE GROUND AND KEEP IN A DRY, COOL AREA.

SECTION II HAZARDOUS INFORMATION

DUST WILL BE PRESENT WHEN HANDLING. BELOW 30 mppcf OR 10mg/m³ SHOULD BE THE LEVEL MAINTAINED THROUGHOUT THE WORK PLACE'S VENTILATION SYSTEM.

Inhalation: Try to always inhale fresh air.

Over Exposure:

Minor: Can cause skin and eye irritation, dry skin, alkali burns, and upper respiratory problems.

Major: Tissue inflammations in the lining of the nose and cornea, and may cause allergic dermatitis. (May show traces of chromium)

Ingestion: May not cause any side effects.

Eye Contact: Rinse thoroughly with water. See physician if irritation persists.
